Buyer Responsibilities:

Provide dog with routine preventive care, such as annual physical examinations by a licensed veterinarian, and follow veterinarian guidelines for vaccinations and other medications.

Provide dog with a healthy environment using reasonable care and actions to prevent injury and provide for the wellbeing of the dog.

Buyer agrees not to allow this dog to be impregnated or use this dog as a stud. In the case the dog produces offspring, the Buyer must pay to the Seller \$1500.00 for each offspring of this dog including multi-generational offspring of this dog's lineage. This applies even if the Buyer no longer owns the dog and has not returned the dog to the Seller.

Seller Responsibilities:

No-Questions-Asked re-homing policy: The Seller will take ownership of this dog for the purchase price of one dollar at any time the Buyer requests and presents the dog to the Seller. The Buyer is responsible to deliver the dog to the Seller. The Seller will disposition the dog at the Seller's discretion for the health and wellbeing of the dog. There is no refund to the Buyer of the purchase price of the dog.

(Golden Retrievers only) AKC registration of this dog is included and will be transferred to the Buyer upon completion of the sale.

Microchip implantation is included with this dog. Documentation related to the microchip will be provided to the Buyer upon completion of the sale. Registration and any fees associated with the microchip are not a liability of the Seller and not included in the purchase price.

Vaccinations and medications have been administered to this dog while owned by the Seller. The Buyer has been informed of these medications. Continued vaccinations or other medications are not a liability of the Seller and are not provided.

Additional Agreement:

This dog is not required to be spayed/neutered although it is highly recommended. Please consult a veterinarian concerning this matter.

Spaying/Neutering is NOT included in this purchase contract and is not a liability of the Seller.

Seller is not responsible for any medical examinations, procedures, treatment, medications, vaccinations, grooming, or other expenses incurred by the Buyer. Buyer is aware that owning a dog requires veterinarian and health care expenses.

There is no guarantee that this dog will be fertile or have reproduction function.

There is no guarantee and no refund based on the size or weight attained as an adult or to the show-ability or usability of this dog for any purpose.

No refund will be given due to dissatisfaction with the temperament, trainability, coat type/quality or shedding, allergic reactions of the dog or persons in proximity to this dog, cost of care or feeding, damages caused by or as a result of this dog, buyer's remorse, or other inherent characteristic of the dog except as covered by the Limited Health Warranty.

If this dog is returned for any reason other than what is covered in the Limited Health Warranty there is NO refund or exchange.

If the payment for this dog is not completed, i.e. insufficient funds, the Buyer will be liable for all bank and/or legal fees incurred by the Seller to obtain the agreed payment.

This contract supersedes any and all previous agreements for this dog.

Buyer agrees that he/she understands this contract fully.

Legal Remedy:

If for any reason legal action becomes necessary by either party any suit or action is required to be filed within Oakland County, Michigan. In the event that there is any controversy or claim arising out of or relating to this contract, or to the interpretation, breach, or enforcement thereof, and any action or proceeding is commenced to enforce the provisions of this contract, if the Seller is the prevailing party, the Seller shall be entitled to a reasonable attorney's fee, costs, and expenses from the losing party.
